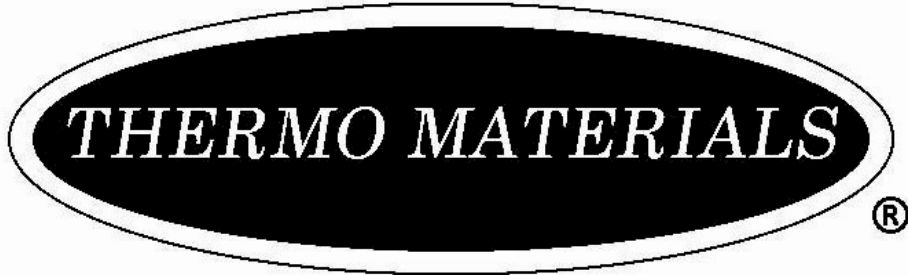

**General Terms:** If this Credit Application is accepted, Applicant agrees to pay in full the invoice price of all purchases now or hereafter made from Thermo Manufacturing Systems, LLC when due, according to the terms set forth on each invoice. Execution of this document does not create an exclusive agreement with Thermo Manufacturing System, LLC and the undersigned unless specifically stated.

**Late charge/interest:** If the total invoice price is not paid in full on or before 60 days from the date of invoice, Applicant agrees to pay a late payment charge on the unpaid delinquent balance. The late payment charge shall be equal to 2% of the unpaid delinquent balance per month.

**Reservation of Rights:** Thermo Manufacturing System, LLC reserves the following rights: (1) to cease shipping on accounts that remain unpaid 60 days from date of invoice; (2) to require payment checks on any given Construction Project to be issued jointly to Thermo Manufacturing Systems, LLC and Contractor by Owner; (3) to cancel the extension of credit at any time; and (4) to demand payment in full of the balance of any account that remains unpaid 45 days from date of invoice; and (5) items returned to stock must be prepaid (shipping) by applicant. After full inspection by Thermo Manufacturing Systems, LLC, a 20% re-stocking fee will be billed on all items along with charges for any defective items.

**Provision of certain information:** Applicant agrees to provide to Thermo Manufacturing Systems, LLC upon request certain information regarding bonding companies, construction contracts, legal property descriptions, Contractor, and/or Owner for purpose of filing mechanic's and materialman's notices, affidavits and/or claims on payment bonds.

**Authorizations:** Applicant authorizes Thermo Manufacturing Systems, LLC to obtain any and all information Thermo Manufacturing Systems, LLC deems necessary from any and all sources or references listed on the Credit Application, and any other credit bureaus or reporting agencies, creditors of Applicant, trade references, banks or other financial institutions for Thermo Manufacturing Systems, LLC use in determining whether to accept the Credit Application. Applicant agrees to indemnify and hold any creditor harmless for provision of credit information on Applicant to Thermo Manufacturing System, LLC in connection with the Credit Application.

**Representations:** Applicant represents to Thermo Manufacturing Systems, LLC, and Thermo Manufacturing Systems, LLC is relying upon in its determination of whether to accept the Credit Application, the following representations: (1) the individuals signing the Credit Application have authority to do so on behalf of the Applicant; (2) that any and all information now or hereafter supplied to Thermo Manufacturing Systems, LLC by Applicant, or at Applicant's request or instruction, is both accurate and complete; (3) that Applicant shall promptly notify Thermo Manufacturing Systems, LLC of (a) any change in any information supplied in the Credit Application; (b) any change in Applicant's residence, chief place of business or mailing address; (c) any change of name or business of Applicant, including in the event that Applicant incorporates under the laws of any State subsequent to the date of the Credit Application; and (4) that Applicant, if also Owner, does not use any portion of the real property upon which the Construction Project is located as his or her homestead, whether rural or urban, personal or business and will provide a designation of his or her homestead in accordance with the requirements of Texas Property Code §41.005 **prior** to purchasing from Thermo Manufacturing Systems, LLC.

**Default:** The occurrence of any of the following events shall constitute a default: (1) Applicant fails to fulfill any obligation under the terms of this Credit Application; (2) Applicant, or the guarantor of Applicant's indebtedness, dies, terminates existence, abandons its business, becomes insolvent, or becomes the subject of bankruptcy, receivership, insolvency or a similar proceeding; and/or (3) Any information or representation hereunder is, or is believed in good faith by Thermo Manufacturing Systems, LLC to be, inaccurate, incomplete, or false in any material respect.

**Attorney's fees:** Applicant agrees to pay Thermo Manufacturing Systems, LLC the expenses of collecting any unpaid delinquent balance, including attorney's fees and costs should legal action be required.

**Jurisdiction and venue:** The terms of the Credit Application shall be construed upon the laws of the State of Texas. In the event that legal action is necessary, venue for said action shall be in Smith County, Texas, where all billings, accounts receivable, and credit functions of Thermo Manufacturing Systems, LLC are processed at its principal place of business in Lindale, Smith County, Texas. Applicant understands that it waives its rights to litigate any cause of action arising out of the purchase of materials under the extension of credit in the Credit Application outside of Smith County, Texas.

**Binding agreement:** The terms of this Credit Application shall inure to the benefit of the successors and assigns of Thermo Manufacturing Systems, LLC and Applicant binds its heirs, legatees, devisees, personal representatives, successors and assigns thereto.

**Definitions:** The following definitions apply to the terms of the Credit Application: (1) "Applicant" is the person, whether singular or plural, or entity on whose behalf Thermo Manufacturing Systems, LLC extends credit under the Credit Application, (2) "Construction Project" is the project or projects for which Thermo Manufacturing Systems, LLC produces materials for Applicant's use, (3) "Contractor" of the Construction Project is the person contracting with Owner for the construction of improvements to real property for a particular Construction Project, (4) "Credit Application" is the agreement, the terms of which are specified in this written application for credit from Thermo Manufacturing Systems, LLC, and any invoices incident thereto, (5) "Owner" is a person, whether singular or plural, or entity holding legal title to the real property upon which the Construction Project is or is to be situated.

The guarantor whether singular or plural, waives any notice requirement concerning enforcement of this personal guaranty and further acknowledges that Thermo Manufacturing Systems, LLC may pursue collection of the indebtedness guaranteed without the necessity of first pursuing collection from Applicant. The indebtedness guaranteed includes the renewal of any claims or extensions of time for payment thereof, without further notice to the individual(s) guaranteeing same. The personal guaranty is binding upon the individuals signing the Credit Application, their heirs, successors, legal representatives and assigns. The personal guaranty remains in full force and effect until it is revoked, in writing, sent by certified mail to Thermo Manufacturing Systems, LLC at the address herein.
